**CHINALCO WON THE BID IN RELATION**  
**TO THE ALUMINIUM FABRICATION INTERESTS**

This announcement is made by Aluminum Corporation of China Limited\* (the “**Company**”) pursuant to Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rules 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

Reference is made to the announcements of the Company dated 9 May 2013, 16 May 2013 and the supplemental circular of the Company dated 7 June 2013 (the “**Supplemental Circular**”). Unless the context requires otherwise, terms used herein shall have the same meanings as those defined in the Supplemental Circular.

On 13 May 2013, the Company submitted the tender notice to CBEX so as to dispose the Aluminum Fabrication Interests by way of open tender. Chinalco, the controlling Shareholder of the Company, participated in and won the bid for the Aluminum Fabrication Interests on 7 June 2013. The Company will enter into the Aluminum Fabrication Interests Transfer Agreement and the Loan Transfer Agreement with Chinalco on or before 11 June 2013. In accordance with the requirements of Chapter 14 and Chapter 14A under the Hong Kong Listing Rules, the Company will publish an announcement in relation to the Aluminum Fabrication Interests Transfer Agreement and the Loan Transfer Agreement immediately after the execution date of such agreements.
